1. <u>CALL TO ORDER.</u>

Mayor Nicholson called the meeting to order at 2:00 p.m.

2. RECEIVE PRESENTATION FROM PONCA CITY MAIN STREET (PCMS) RELATING TO POTENTIAL CREATION OF A BUSINESS IMPROVEMENT DISTRICT (BID) IN THE CENTRAL BUSINESS DISTRICT.

Terron Liles, of Liles & Company, went through a powerpoint presentation from PCMS. He began by reviewing the Ponca City 2008 Comprehensive Plan, as it relates to downtown. Liles then reviewed current investment and projects that are improving downtown, as well as barriers to building improvements in the area.

Liles continued with a proposal for a Business Improvement District (BID) and explained details, including funding by private sector buy in through assessment. Liles concluded with the vision that PCMS has for downtown, and solicited questions. Discussion ensued.

3. RECEIVE PRESENTATION FOR A PROPOSED ORDINANCE AMENDING THE CITY CODE BY CREATING SECTION 7-2D ESTABLISHING TRUANCY AS AN OFFENSE WITHIN THE CITY OF PONCA CITY.

Assistant City Attorney John Andrew gave background on the problem of truancy in our schools, and current practices. The proposed ordinance would give the school resource officers the authority to act on the problem. Andrew then gave specific examples of how the proposed ordinance would be applied. Discussion ensued.

Environmental Services Director Hong Fu reviewed a powerpoint presentation where curbside recycling would be offered to Ponca City residents by SCL, on a subscription basis. She gave details on the current agreement with SCL to operate the Recycling Center, as well as details on SCL's proposal for new service. Fu continued, outlining advantages of curbside recycling the community and the City. Discussion ensued.

Mayor Nicholson congratulated City Manager Craig Stephenson for his recent induction into the Oklahoma Hall of Fame for City and Town Officials. Nicholson noted that the recent OML Conference was a nice learning and networking experience.

Commissioner Chapman also congratulated Stephenson on the award.

Stephenson informed all that the ABLE Commission will be holding a Kay County Town Hall this Thursday, at Pioneer Technology Center, on the new alcohol laws. Stephenson concluded by updating commissioners on his upcoming schedule of training.
