REPORTS

10. <u>CITY MANAGER'S REPORT</u>

City Manager Craig Stephenson let the public know that Ponca City Energy has contracted with Mid-Con Energy for several transmission pole replacements starting north of Lake Road on Pecan Road. Construction on the project began today November 11, 2019, and will continue through the week. Please be aware of large trucks entering and exiting Pecan Road while accessing utility easement to complete project. A slight road closure will be required on November 14, 2019 from 9:00 a.m. to 1:00 p.m. During closure the Ponca City Country Club will remain accessible from Lake Road and all residents north of the Country Club will remain accessible from Hartford Avenue. All efforts will be made to minimalize road closure and open Pecan Road back as soon as possible.

Stephenson also let it be known that the City of Ponca City has contracted with Evans & Associates for a street improvement project on Hartford Avenue and Kygar Road. Construction on the project began November 11, 2019. The work begins on Hartford Avenue at Academy Road and extends east around the curve at Kygar Road, and then south on Kygar Road approximately 1600 feet. Portions of the roadway will be milled and overlaid and will remain open to local residential traffic only. The curve will be reconstructed and will be closed to all traffic during construction. Local residential traffic will access Academy Road and Stoneridge Road on Hartford Avenue from the west only. Access to West Lake Ponca will be on Kygar Road from the south only. The contract time for this project is 45 calendar days. Stephenson mentioned the upcoming holiday and the City of Ponca City offices will be closed November 28, 2019 and November 29, 2019 for the Thanksgiving Holiday.

Stephenson announced that in celebration of Native American Heritage Month, the Native American Collection at Marland's Grand Home will be featured on *Discover Oklahoma* on December 7, 2019 at 6:30 p.m. on KFOR TV channel 4, KTUL TV channel 8, and KSWO TV channel 7.

The City's Crew will be working the City section by section, so it may take two weeks or more to collect the leaves due to the large volumes expected. Leaf collection will also be available by special pickup anytime during the year. Call 767-0411 for information on special pickups. Special pickups carry a minimum charge of thirty-nine dollars and nine cents (\$39.09).

The range of support of assistance shall not be extended to include persons in drug, alcohol, juvenile, child, parole, family shelter, battered spouse shelters, half-way houses, and other programs of treatment, and care supervision and is subject to annual inspections by the City until such time that the commission is comfortable with the operations of the facility.
